Player & Parent Financial Agreement for Northern Eagles Volleyball Academy

Base Price for 2021-2022 NEVA Club Season: \$1200

Player and Parent understand and agree to pay a deposit to NEVA during/after tryouts to hold their roster spot for the 2022 club season, of which the deposit will be applied to their total club base fees for the season. Player and Parent also understand that any money deposited is non-refundable should the player or parent change their mind and opt not to participate in the program. Player and Parent agree to pay monthly installments due by the 1st or the 15th of each month until their balance is \$0.00 so that the player can participate in the 2022 club season.

Parent and Player agree to pay the total fees due on time as laid out in this payment agreement. Player and Parent understand that all payments must be received by Northern Eagles Volleyball Academy by and no later than 2 days after the payment day you circled to be considered on time. Player and Parent understand there is a \$20.00 late fee per day for all monies collected after the agreed upon date.

If you decide you would like to pay the base price in one payment, NEVA will offer a 10% discount off base price. Please Check below for full base price payment – 10% discount.

Parent and Player understand that there are no refunds of any monies paid once a player accepts a spot on a team. For any reason up to and inclusive of injury, mental health, family relocation, dismissal from program due to violation of Northern Eagles Volleyball Academy Policies, USAV Policies, or AAU Volleyball Policies.

Parent and Player understand that monies paid to Northern Eagles Volleyball Academy do not guarantee any amount of playing time, positions within a team lineup, leadership roles, or duties.

Player and Parent understand that monies being paid to participate in the 2022 season constitutes a commitment to Northern Eagles Volleyball Academy as a whole and not one specific team. In rare events, some players may be moved to other teams for competition purposes. The Parent and Player agree that they are responsible for their signed and agreed upon team fees regardless of the team they compete on for any given event. Northern Eagles Volleyball Academy will not seek further compensation if a player moves rosters at clubs 'discretion, however if the Parent or Player requests a team change that is in excess of their current fee agreement, they are responsible for the additional fees.

Parent and Player understands that all team fees are to be paid using cash, check, Venmo, and all major credit cards (using square).

Furthermore, Parent and Player agrees that Northern Eagles Volleyball Academy is providing a service, rather than a product, and therefore waives the right to dispute any payment for services made via cash, check, credit, or debit card to Northern Eagles Volleyball Academy.

Parent and Player understand that the following items are INCLUDED of their Club Base Fees:

- Uniforms/Sports Package- 2 custom jerseys, club choice of sweats or shorts, hoodies or jackets, backpack or duffel bag, 2 practice shirts
- Tournament Fees 4- 1day tournaments, 1- 2day tournaments
- Coaching Fees
- Practice Court Fees
- Equipment Fees
- Administrative Fees
- Scorekeeping/Referee Clinic Fees
- Summer clinics June & July

Parents and Players understand that the following are NOT INCLUDED in their Volleyball Club Base Fees and are additional costs:

- Cost of Travel for players/parents, Hotel stays and play, Coaches pay and stay, tournament fees, penalty fees of tourney (if necessary)
- USAV Membership Fees
- Practice facility rental fees during time to prepare for travel event.
